**SUBJECT: Government Grant Funding Update** 

ORIGIN: Strategic Initiatives Office

In accordance with the Town's Procedural Bylaw, any Member of Council may make a request to the Town Clerk that this Information Report be placed on an upcoming Committee of the Whole agenda for discussion.

### **COMMENTS**

This report provides members of Council with an update to Joint Office of the CAO, Commissions of Development and Infrastructure, Community, and Corporate Services Information Report 2016-12 dated August 10, 2016 regarding Federal Infrastructure Funding Update, subsequent to Joint Office of the CAO, Commissions of Development and Infrastructure, Community, and Corporate Services Information Report 2016-08 dated May 16, 2016 regarding Federal Infrastructure Funding.

Informing Council of federally and provincially funded capital projects is a priority to staff. Approved grants can provide a relief to the operating and capital budgets, and specifically longer term impacts on the Asset Replacement Fund.

The following chart summarizes all infrastructure related applications submitted:

The results of the Federal government's review for the 8 grant applications submitted through the Clean Water Wastewater Fund remain pending at the time this report was prepared. Appendix 'A' attached to this report provides further details on the 12 grants approved for scheduled infrastructure projects funded. Only one project, the Integrated Audio System at the Seniors Meeting Place, is fully funded through the New Horizons for Seniors grant program. Newmarket's contributions to supplement all other grants received for the projects listed will be funded through the Asset Replacement Fund. The most recent announcement received from Service Canada at the end of March advised of Newmarket's success to fund one accessibility upgrade to park washrooms at Ken Sturgeon park through the Enabling Accessibility Fund. Initially three applications were submitted and denied; however, the federal government advised staff that additional funds had subsequently become available due to incomplete applications from previous years and that they intended to distribute the additional funds as widely as possible to the benefit of as many municipalities as possible.

Staff are currently reviewing federal and provincial budget announcements to identify opportunities to align and prioritize infrastructure projects that would otherwise not be funded through Development Charges, the Asset Replacement Fund or Other Reserve Funds for projects anticipated to be implemented between 2018 to 2025 as recommended in Joint Office of the CAO, Commissions of Development and Infrastructure, Community, and Corporate Services Information Report 2016-08 dated May 16, 2016.

#### STRATEGIC AND BUSINESS PLAN LINKAGES

This report supports and aligns with:

- the Town's Strategic Plan vision of "Being Well beyond the ordinary" in all five strategic directions;
- Council's Strategic Priority theme of Efficiency / Financial Management;
- all six of the Strategic Leadership Team's priority areas, but more particularly EVEN better matching resources with priorities, EVEN better tracking of success, and EVEN better communication; and
- 2016, 2017 and 2018 Budget priorities.

## CONSULTATION

This report is being concurrently circulated to the Strategic and Operational Leadership Teams for information purposes.

#### **HUMAN RESOURCE CONSIDERATIONS**

Grant related activities from sourcing, coordinating, writing, submitting, through to executing agreements has had an impact on staff resources and is expected to continue with future federal and provincial announcements for upcoming intakes in 2017 and beyond. At this time, it is difficult to assess the full-impact on current staffing levels and/or resource needs.

Grant writing consulting services will continue to be leveraged to fill the current gap in staff

resources in order to meet the tight turnaround times between grant announcements and

application due dates as previously experienced during the first intake for both federal and provincial funding applications last year.

### **BUDGET IMPACT**

# **Operating Budget and Capital Budgets (Current and Future)**

There is no immediate operating or capital budget impact as a result of this report.

There may be a need to access grant writing consulting services for future applications which may result in an operating budget impact depending on the intake cycle of application streams and departmental business cycles.

Future successful grant applications for funding capital projects planned for 2018 and beyond will provide relief to capital budget requests and reduce future draws on the Asset Replacement Fund and operating budget impacts where eligible. Staff may also need to re-prioritize and/or defer scheduled infrastructure projects to capitalize on available grant funding opportunities and monies awarded.
