**New Parking Ticket Solution** 

**ORIGIN:** 

Legislative Services

In accordance with the Procedure Bylaw, any Member of Council may request, through the Clerk that this Information Report be placed on an upcoming Committee of the Whole agenda.

## **COMMENTS**

The purpose of this information report is to advise Members of Council that staff in 2016 had an RFP 2016-32 issued to replace the current Mobile handhelds for parking citations along with hardware and parking software.

The new parking ticket solution (AIMS) is a complete integrated software solution managing all aspects of parking tickets and parking permits. It will provide the municipality with a complete real time solution for parking management. It will also have a self-service e-commerce portal for individuals to pay parking or appeal parking tickets online, without the need for in-person application/payments.

The AIMS Mobile Android App will also be implemented. The AIMS Mobile Android App utilizes an Android Device (provided by the Town), along with a separate Bluetooth Printer (Zebra ZQ510). Utilizing the Android device allows the AIMS Mobile App to provide instant real-time communication from the field to the AIMS database which includes:

- Real time transfer of ticket data upon issuance, including officer notes and digital images
- Real time lookup of vehicle warning information
- Real time lookup of previous ticket history including balances
- Real time lookup of vehicle permit information
- Real time GPS tracking of officer locations
- Real-time payment utilizing a smartphone.

Another feature includes a public Web portal allowing residents to apply for parking exemptions. As part of the self - service option, this will decrease the calls to our afterhours call centre which in return will decrease the costs for Customer Services Department and staff time.

Parking fines have not increased since 2006 and as part of a comprehensive review, the 2016 budget included new fines which were subsequently approved by the Attorney General's Office.

The new parking fines were put on hold to coincide with the planned implementation of the new parking solution in 2017.

The new parking solution along with the public Web portal and the new fines will be going live on Monday November 20, 2017.
