Accountability and Transparency Measures 2023 Information Report

In accordance with the Procedure By-law, any member of Council may make a request to the Town Clerk that this Report be placed on an upcoming Committee of the Whole agenda for discussion.

Purpose

This report provides an update for matters relating to the Ombudsman, Integrity Commissioner, Closed Meetings and Freedom of Information requests for 2023; and all delegated matters carried out by staff in accordance with Delegation of Authority By-law 2016-17 for 2019 through 2023.

Background

Legislation surrounding municipal accountability and transparency includes a range of oversight and reporting requirements. Sections 223.1 through 223.24 of the Municipal Act, 2001 set out several accountability and transparency measures municipalities are required to follow, and Section 239 provides various exceptions to the open meetings rules which allow Council to hold a meeting that is closed to the public. Combined with other legislation, such as the Municipal Freedom of Information and Protection of Privacy Act, these measures provide a framework to ensure consistency and transparency in municipal processes.

- 1. **The Customer Complaints Policy** provides processes for the Town to address complaints related to services delivered by the Town.
- 2. **The Provincial Ombudsman** reviews complaints that are escalated by a complainant for services provided by the municipality. The Provincial Ombudsman also provides closed meeting investigations in the event of a complaint regarding a closed meeting of Council.

- 3. **The Integrity Commissioner** is an independent officer who reviews complaints of Council and Committee member conduct. The Integrity Commissioner also provides proactive advice, education, and training upon request from Council or a Member.
- 4. **The Freedom of Information process** under the Municipal Freedom of Information and Protection of Privacy Act allows members of the public to request copies of Town records, thereby increasing transparency. In addition to the Freedom of Information process, the Town's Routine Disclosure Policy allows staff to disclose certain types of records to the public without going through the formal legislated process.
- 5. **The Delegation By-law 2016-17 as amended** delegates authority to staff to carry out certain actions on behalf of Council. The delegation by-law allows for operational efficiency and effective customer service. Reporting on delegated matters is a new addition to this annual report. It was previously provided to Council under a separate report and is being included on all Accountability and Transparency Measures Reports to Council on a go forward basis.

Discussion

Complaint Policy

Through the various stages of the Customer Complaint process, the Manager of Corporate Customer Service reviewed eleven complaints, providing guidance and/or feedback to staff where appropriate, assisting with the de-escalation of various issues as well as with educating residents regarding Town by-laws or practices. These reviews included complaints that were deemed to be frivolous and/or vexatious, neighbour disputes that would be more appropriately addressed in civil courts and, in some instances, referrals made to the Office of the Provincial Ombudsman as the matter was now deemed closed from the Town of Newmarket's perspective. Consultations took place with Town solicitors where appropriate.

Several matters were referred to the Customer Complaint Policy from Town staff in various departments, for assistance in navigating complaints related to service delivery, responsiveness, and existing practices. The Manager of Corporate Customer Service undertook investigations and made recommendations related to processes and policies, where appropriate.

Ombudsman

There was one complainant who filed a complaint with the Ombudsman's office in 2023. The matter was regarding the issuance of a trespass notice by Municipal Enforcement staff related to an individual who was confronting Town staff and residents at the municipal offices. A thorough investigation was undertaken by staff at the Office of the Provincial Ombudsman. It was subsequently determined that the matter was handled appropriately, some recommendations were made to the Town and the file was closed.

Accountability and Transparency Measures 2023

Closed Meeting Investigator

In 2023 the Town held twelve closed session meetings and there were no closed meeting investigations. Notice of all meetings was provided by public posting meeting agendas at www.newmarket.ca/meetings which outlined the topic and corresponding exception from Section 239 of the Municipal Act.

Integrity Commissioner

The Town's Integrity Commissioner Robert Swayze dealt with two complaints from members of the public related to Council conduct in 2023. One complaint was ongoing from 2022 and the other was dismissed.

Freedom of Information Requests

In addition to the summary below, **Attachment 1** provides statistics and summary information on FOI requests filed with the Town for 2023.

- 54 FOI requests received.
- Average response time: 22 days

One decision was appealed to the Information and Privacy Commissioner. The matter is still ongoing.

Delegation of Authority

Following the last staff report on delegated matters to Council on March 6, 2019 through Information Report 2019-01. Due to Covid-19, together with attention on multiple high priority and time sensitive matters (which have been separately reported on to Council), the delivery of what has always been intended to be an annual summary report to Council on delegated operational matters has been delayed. All delegated matters from 2019 through 2022 were tracked by Legal Services and have been attached as **Attachment 2**. In 2023, this reporting function was transferred to Legislative Services to include with the annual Accountability and Transparency Report. All matters carried out by staff pursuant to Delegation By-law 2016-17 in 2023 are summarized in **Attachment 3**. Legislative Services staff will resume reporting to Council on an annual basis as part of the annual reporting on Accountability and Transparency.

Matters that have received separate Council approval are not included in this report. Procurement matters are reported to Council separately in accordance with the Procurement By-law.

Conclusion

Town staff continues to be proactive in the disclosure of information and in finding ways to enhance efficiency and transparency in relation to records, information, and decision making throughout the Town of Newmarket.

This report relates to long term financial sustainability through continued evaluation and analysis of the Town's service levels and continuous improvement of our accountability and transparency measures.




