### **Purpose**

To provide an annual update on the progress of the five-year MoveSmart Mobility Management Strategy highlighting achievements in support of Council's commitment to provide a transportation system that is safe, more efficient, and sustainable.

## **Report Highlights**

- On March 10, 2021, Council endorsed the five-year MoveSmart Mobility Management Strategy (MoveSmart Strategy).
- Road safety, active and sustainable travel, and effective traffic management remain a top priority as Vaughan continues to experience significant growth.
- Fourteen out of the twenty-nine MoveSmart Strategy initiatives have started, or are ready to start, in 2022 with two specific initiatives brought forward from future years that include the Road Safety Strategic Plan and the Intelligent Transportation System Strategy.

## **Report Highlights continued**

- Progress has been made within all four programs of the MoveSmart Strategy. Piloting new traffic calming measures within existing school zones, the rollout of the City's Slow Down lawn sign campaign, the implementation of a new speed limit policy, the acquisition of a Traffic Data Management System and the use of smart technology enhancements to both the streetlights and traffic signals network are some of the more notable accomplishments.
- Building partnerships with stakeholders and raising public awareness continue to be integrated into this strategy with a key focus on building a road safety culture based on shared values and responsibilities.

## **Background**

On March 10, 2021, Council endorsed the MoveSmart Strategy that set the direction and priorities for the next five years; to create a progressive and holistic traffic management and mobility plan for all road users.

With significant population and employment growth expected within the next ten years, the road network throughout the City of Vaughan continues to expand and the number of daily trips made in and out of the City is expected to increase. This creates many operational challenges on the City's road network including increased congestion and potentially more conflicts between vehicles, cyclists, and pedestrians. Despite these challenges, a high level of safety is expected from Vaughan's citizens.

## Road safety, maximizing existing road capacity, and providing alternative active and sustainable transportation modes continue to be the City's top priorities.

In response to the substantial growth on the road network and guided by extensive input from key stakeholders and feedback from the public, staff developed the MoveSmart Strategy to direct the development of operational policies, allocate resources and establish priorities. Since the adoption of the Strategy, staff organized the City's mobility related services into the four highly integrated programs; road safety, mobility management, sustainable mobility and traffic data management. For more information Item 1 on these programs, please refer to Attachment 1, page 8 of the 2022 Annual Report - *MoveSmart Mobility Management Strategy*.

The Strategy is designed to routinely adapt to the needs of the City's transportation network. It will also be updated every five years (in parallel with the Transportation Master Plan) to reflect changes in growth, the availability of new technologies and to align with the City's term of Council priorities.

## Analysis and Options

Progress has been made in all four MoveSmart Strategy programs.

Going into 2022 the MoveSmart Strategy is proving highly effective at achieving its aspirational goal; to provide consistent, reliable, and safer streets for all road users. The four MoveSmart programs encompass twenty-nine initiatives, fourteen of which have commenced or are ready to commence.

Three staff have been added to help develop and manage the foundations of the Strategy. Additional staffing resources are required over the next four years to continue to implement, manage and operate the various initiatives within the strategy.

Some of the more notable achievements to date include piloting new traffic calming measures within existing school zones, the rollout of the City's Slow Down lawn sign campaign, the implementation of a new speed limit policy, the acquisition of a traffic data management system and smart technology enhancements to the streetlight system and upgrade to the traffic signals network.

A comprehensive list of achievements from the first year of the MoveSmart Strategy and key planned initiatives are contained in Attachment 1, pages 12 to 23 of the 2022 Annual Report - MoveSmart Mobility Management Strategy.

Building partnerships with stakeholders, public engagement and public awareness initiatives continue to be instrumental components of the MoveSmart strategy, with a focus on safer transportation mobility options for vulnerable road users.

The City continues to leverage partnerships with both internal and external stakeholders to help foster shared values and responsibilities when it comes to road safety. Collaboration to help raise awareness, enable communications, and share road safety information is key in building a road safety culture.

Key public awareness initiatives achieved and planned under the MoveSmart Strategy are contained in Attachment 1, page 24 of the *2022 Annual Report - MoveSmart Mobility Management Strategy*.

Over the next few years, MoveSmart will continue to guide the City in achieving the vision of providing a transportation system that is more safe, efficient and sustainable. To realize this vision, the MoveSmart Strategy will endorse road safety procedures that identify locations with the highest potential to improve safety and bring together stakeholders to integrate programs and safety knowledge to improve the City's roads

and trail systems. The strategy will continue to focus on managing congestion and optimizing the existing road network. With the newly acquired traffic data management system, the City will be able to make evidence-based decisions and assess the effectiveness of new policies and changes on the roadways.

## Financial Impact

## There are no financial impacts associated with this report.

Cost estimates for the various initiatives continue to be further refined as projects are implemented and additional funding will be requested through the annual budget process. Staff will continue to explore opportunities, partnerships, and alternative funding sources to help support the strategy implementation.

## **Broader Regional Impacts/Considerations**

Since the City's transportation system is integrated with the Regional road network and adjacent to those of other local municipalities, it is critical that the MoveSmart Strategy is implemented in coordination with these other key stakeholders. Staff have begun to engage with the Regional Municipality of York by sharing data through its traffic data management system and are also pursuing a collaborative partnership in the development of a Road Safety Strategic Plan. Furthermore, York Regional Police, York Region School Boards, York Region Public Health, along with other City Departments continue to play a vital role in the MoveSmart Strategy with a focus on stakeholder engagement and public awareness initiatives within the four MoveSmart Strategy programs.

## **Conclusion**

Since the endorsement of the MoveSmart Strategy in March 2021, progress has been made or is ready to commence on fourteen of the twenty-nine initiatives.

Building partnerships and collaboration with key stakeholders continue to be a key focus to help raise awareness, enable communication, and share information in building a road safety culture focused on safety, mobility, sustainability, and data. As the programs in the strategy continue to be implemented, the vision of a safer, more efficient, and sustainable transportation system is being realized.

Staff recommend that Committee receive this first annual MoveSmart Strategy report and presentation outlining the achievements to date as information.



## MESSAGE FROM THE **DIRECTOR**






# **MOVESMART AT-A-GLANCE**

The City of Vaughan is one of Ontario's fastest growing municipalities, with a population today of over 340,000 people and a forecast of 570,000 people by 2051. Employment is expected to keep pace with population growth, increasing from 240,000 jobs in 2021 to over 350,000 jobs by 2051. With such high population and employment growth, the number of daily trips made by Vaughan residents and businesses, and external trips in and out of Vaughan, are expected to continue to increase over and above the rapid increases experienced over the last 25 years.





#### **MOVESMART** | 2022 MOBILITY MANAGEMENT STRATEGY



To keep up with the increase in trips, the road network throughout the city of Vaughan continues to expand; new roads and recreation trails have been created to serve new development, and existing roads are being widened. This expansion creates many operational challenges in all parts of the City, including more construction, more controls for traffic and more vehicles, cyclists and pedestrians.

In response, the City initiated the MoveSmart Mobility Management Strategy (MoveSmart) in 2021. The strategy integrates existing activities and projects, leverages research on trends and best practices, co-ordinates with internal departments and intends to change mindsets through public engagement. The MoveSmart Strategy consists of four highly integrated programs:

## **Road Safety**

### to increase road safety and raise public awareness

- To bring together key stakeholders to keep the City's streets safer for all road users and promote a road safety culture
- To take a more proactive approach to road safety by using data and proven statistical procedures and identify additional road safety opportunities

## **Mobility Management**

### to improve efficiency through innovation and technology

- To modernize the City's traffic signals system, providing more efficient traffic flow and link to existing and future technologies
- To ensure pedestrians, cyclists and vehicle traffic continue to move safely and efficiently through signalized intersections and pedestrian crossings using the existing road network

## **Sustainable Mobility**

## to support active and sustainable transportation

- To support the development of additional active and sustainable transportation options and ensure that they focus on the safety of all road users
- To support the expansion of the pedestrian and cycling network through consideration of the operations and maintenance services

## **Traffic Data Management**

## to assure accuracy and availability of traffic data

- To modernize traffic data management with up to date traffic data to form the core of the Strategy and support data-driven and evidence-based decision-making
- To have traffic data to allow for ongoing tracking of performance of the transportation system over time



# **MOVESMART AT ONE YEAR**

The MoveSmart Strategy is designed to continuously adapt to the ever-changing dynamics of the city's travellers, take advantage of new or emerging technologies and leverage opportunities as they become available. In this way, the strategy can continue to support the City's changing goals and priorities.

## Accelerating the Plan

Fourteen out of the 29 MoveSmart Strategy initiatives have started, or are ready to start, in 2022 with two specific initiatives brought forward from future years that include the Road Safety Strategic Plan and the Intelligent Transportation System Strategy.



The City continues to build partnerships with York Region, York's school boards and the York Regional Police. In addition, three staff positions have been created to support the strategy. The acceleration of the Road Safety Strategic Plan initiative will allow the City to realize a safety plan sooner and leverage it as a guide to focus resources and the investments of our partners on road safety improvements. By accelerating the schedule, a Road Safety Strategic Plan can be realized by the end of 2023.

Smart streetlights are gaining attention as a future interface to the public. Smart streetlights connect with a wide range of devices, including electronic banners, environmental sensors, parking monitoring devices, cameras, traffic and pedestrian sensors and WiFi. They also monitor and control the street lighting; dimming when there is no activity and brightening when pedestrians or cyclists are detected. When streetlights need service or repair, maintenance personnel can issue alerts for a response.

The schedule for the Intelligent Transportation System (ITS) Strategy and Plan has also been fast-tracked to take advantage of the outcomes of the Traffic Control System and Upgrades and the Smart Streetlights initiatives. As the procurement of the traffic control system proceeds, new opportunities emerge, including the integration of other field equipment, new sources of data and the integration of several ITS systems. A plan is needed to guide the City's actions around these new opportunities and to optimize the benefits they provide.



# **ROAD SAFETY PROGRAM**

Road safety has been identified as one of the top priorities for Vaughan citizens. The Road Safety Program is designed to create a culture of safety for all road users through partnerships and education. It consists of a set of initiatives that are carefully followed to monitor, assess and improve the safety performance of a roadway network.





- ✓ Staff participated in the Ontario Traffic Council (OTC) Automated Speed Enforcement (ASE) Municipal Working Group to guide the planning and development of the ASE program guidelines

## What's Next

- Monitoring York Region's two-year ASE pilot project (to be completed by the end of 2022) to serve as the blueprint for the City's program
- Establishing criteria for candidate areas for ASE within the City (2022)
- Staff continue to work with York Region, OTC, and other municipalities to advocate for an ASE program using an Administrative Monetary Penalty System (AMPS)

# **MOBILITY MANAGEMENT PROGRAM**

## **GOAL:** Improve efficiency through innovation and technology

- To modernize the City's traffic signals system, providing more efficient traffic flow and link to existing and future technologies
- To ensure pedestrians, cyclists and vehicle traffic continue to move safely and efficiently through signalized intersections and pedestrian crossings using the existing road network



The City of Vaughan requires the necessary systems, policies and plans to address the complex mobility needs across the city. The Mobility Management Program includes initiatives that allow the City to acquire and operate traffic management systems such as traffic signals, cameras, sensors, variable message signs and other technologies and to use these systems to manage traffic and record traffic data. It also includes initiatives needed to maintain pavement markings and signs that will enhance safety and support sustainable mobility. Lastly, some initiatives involve the development of plans and frameworks to assure optimal integration of these systems and services with the required resources at the most appropriate time.

# Traffic Control System and Upgrades

## Accomplishments

 ✓ Developed a methodology and plan for the Intelligent Transportation System (ITS) and Traffic Management Centre



- ✓ Upgraded 25 signalized intersections with LED traffic signals with reflective backboards and pedestrian countdown timers
- ✓ Continue to co-ordinate and work with internal departments through capital programs to upgrade pedestrian signals to include countdown timers, audible crossing signals (cuckoo and chirp), properly aligned crosswalks with depressed curbs and tactile walking surface indicators that are inlaid in the concrete at intersections
- ✓ Adjusted walk speed at selected intersections to increase walk time for children and older adults
- ✓ Provided lead green time for pedestrians at a pilot intersection to minimize vehicle and pedestrian conflicts (e.g. Clark Avenue at Hilda Avenue)

There are many existing applications (apps) that provide traveller information and trip planning services. In this respect, the City has an opportunity to support and encourage these apps by providing open data. Information that would be highly valuable on an open data platform includes active work zones, locations of traffic signals and crosswalks, recreation trail crossings, school and community safety zones, speed limits, road closures and special events. This information will further improve the effectiveness of the traveller information and trip planning apps.

Smart mobility refers to the use of different modes of transportation alongside, or instead of, gasoline-powered vehicles. Smart mobility includes (among other modes): e-bikes, scooters, skate/long-boards, ridesharing, car sharing and integrated public transportation.



The University of Purdue in the U.S. has developed a set of Automatic Traffic Signal Performance Measures (ATSPM) for contemporary traffic signal controllers. These measures monitor the state of all aspects of the traffic signals (indications, detectors, timers, peripherals, etc.) and are logged 10 times per second. The logs can then be used to assess the signal performance for a wide range of considerations, including timing, unused cycle times, effectiveness of transit signal priority, frequency of pedestrian calls and more. The algorithms and programs that analyze the ATSPMs are available as Softwareas-a-Service (SaaS) over the cloud.



## What's Next

- Procuring a vendor (in progress)
- Planning the development of an advanced traffic signal control system and traffic data management centre (ongoing)
- Preparing for the retrofit of 30 additional signalized intersections with LED traffic signals with reflective backboards and pedestrian countdown timers





# SUSTAINABLE MOBILITY PROGRAM

The City has a progressive track record for constructing state-of-the-art active transportation infrastructure, including recreation trails, pedestrian crossings and cycling lanes. The Sustainable Mobility Program serves to operate and maintain that infrastructure, so it is safe and reliable. Furthermore, considering operations and maintenance requirements during the conceptual design stages results in more efficient and cost-effective services to the public in the long run.

## Pedestrian Infrastructure Enhancement, Cycling Network Expansion and Development Planning

## Accomplishments

- ✓ Continue to co-ordinate with internal departments to advance improvements for pedestrian crossings and cycling networks at various locations across the city
- ✓ Implemented two Type B Pedestrian Crossovers at Valley Vista/South Down Avenue and York Hill Boulevard near Gailcrest Circle
- ✓ Provided input during the feasibility and design study of Clark Avenue
- ✓ Continue to provide insight to help the City's planning and future development in order to design and build safe communities



## What's Next

- To continue to work with internal departments to advance the Cycling Network Expansion Program through the Pavement Marking Design Program.
- Pedestrian Infrastructure Enhancement Plan identified for 2023

## **GOAL:** Support active and sustainable transportation

- To support the development of additional active and sustainable transportation options and ensure that they focus on the safety of all road users
- To support the expansion of the pedestrian and cycling network through consideration of the operations and maintenance services



Today's emerging systems use Artificial Intelligence (AI) to identify pedestrian-vehicle conflicts or non-compliance of pedestrians with traffic signals. These systems consist of cameras installed at intersections and connections to the traffic signal controllers. The intervals of the signal are monitored against the movements of pedestrians. If pedestrians are detected to advance into the crosswalk at any time in the signal cycle (other than during a walk signal) a non-compliance action is recorded. Image processing is used to identify moving vehicles as they come in close proximity to pedestrians and can register a pedestrian-vehicle conflict. These reports can identify safety issues at traffic signals.

Traffic data is at the heart of good decision-making. It can help identify and alleviate mobility issues, focus resources, and guide best practices. The Traffic Data Management Program will allow the City to expand on the traffic data collected, optimize the efficiency and timeliness in which the data is collected, and enable data analysis tools and techniques. By availing the City with timely, accurate and reliable data, the Traffic Data Management Program supports the other three programs of MoveSmart.



#### Overview

This report has been prepared in order to provide Council with some background information on Floating Accommodations and to present a set of comments for endorsement to be sent to the Province.

#### Background

On March 16<sup>th</sup>, County Council assed the following Resolution:

#### Resolution No. 115-2022

Moved by Councillor Moher Seconded by Councillor Clarkson That staff be directed to review the suggestions outlined by the Province in Correspondence item 6 (Appendix A), gather more details and follow along with the process to avoid any issues in the future.

#### Carried

In the preparation of this report, the Provincial Posting on the Environmental Registry was reviewed (<u>https://ero.ontario.ca/notice/019-5119</u>) as well as O. Reg. 161/17: Occupation of Public Lands under Section 21.1 of the (Public Lands) Act.



The Ministry of Northern Development, Mines, Natural Resources and Forestry (MNDMNRF) is aware that the occupation of floating accommodations has raised a number of concerns. "Floating Accommodations" are not necessarily limited to house boats or cabin cruisers but also include other such structures as small cabins that can be used for accommodating people, some with motors or those without motors that are towed out to a location on water and then anchored.

MNDMNRF is not so much concerned with navigation as they are about other matters that have been raised. These include:

- wastewater management
- application of building permits
- duration of use
- advertisings that suggest a range of options for the use of floating accommodations on water
- increasing human pressures on waterways
- impeding access to public land and waterways
- lack of payment of property taxes

While floating accommodations have been viewed by some to represent an economic development and tourism activity, others see the use of floating accommodations as problematic and one which requires further attention.

O.Reg. 161/17 defines "camping unit" as a structure or vehicle that may be used for camping purposes or as an outdoor accommodation and includes a tent, trailer, tent-



trailer, recreational vehicle, camper-back and any watercraft equipped for overnight accommodation.

The ERO posting contains the following explanation:

"A boater may always exercise their right of navigation, which includes reasonable moorage. If a person is not using a "camping unit" or navigating, then occupational authority or other permission is required from our ministry.

We are seeing a change on Ontario's waterways. Over the years, the use of provincial waterways by watercraft has expanded to include floating accommodations, which are designed primarily to provide accommodation for longer stays (i.e., similar to a cottage) and not for navigation or for camping purposes."

#### Analysis

On the previous page, the Province has identified a number of issues related to floating accommodations. However, there are other issues that may deserve some attention as well. These include noise and zoning. Noise By-laws are generally enforced by the local municipality and are usually complaint-driven. By-law enforcement staff will visit the property in question and take appropriate action. However, if the noise originates from a point on the water, does the By-law apply? This legal matter should be investigated by the Province.

With respect to land use planning tools, zoning under The Planning Act is a means to control the indiscriminate use of land. Some local municipalities have taken the position to zone not only lands within their jurisdiction, but also the water bodies. Zoning will specify uses that may occur on the water. They also may trigger a Building Permit for compliance. For those municipalities that have zoning on water, there is a significant challenge in trying to enforce the by-law for floating accommodations whether they be transient or located in one spot for an extended period of time.

It is believed that the Province should review the definition of "camping unit" to narrow the scope of use to account for floating accommodations. Currently, the definition leaves much to interpretation. The other alternative is to define the term 'watercraft" in a way that succinctly describes it to exclude floating accommodations like the ones being addressed.

It is also believed that, if floating accommodations of this nature are to be permitted, there needs to be a permit and location registry system together with a fee structure that is robust enough to finance the administration and on-water enforcement of such activities. Similar to land camping in Provincial Parks, the responsibility should rest with the Province.



With respect to actual house boats and their use on the water, it is strongly suggested that operators have completed and successfully passed certification to obtain a boating licence.

The Province, at this time, is merely seeking ideas and approaches to addressing the issue of floating accommodations. Regulatory changes, if proposed, will be posted on the Environmental Registry for public consultation.

#### Re: Federal Support for Lake Simcoe Clean Up Fund

For your information and records, at its electronic meeting held on March 8, 2022 the Council of the Town of East Gwillimbury enacted as follows:

WHEREAS Lake Simcoe is one of Ontario's largest watersheds, home to First Nations since time immemorial, and situated in the growing communities of Simcoe County, York Region, Durham Region, and the cities of Barrie and Orillia;

WHEREAS the watershed faces threats due to eutrophication, largely from phosphorus runoff and other contaminants into the lake and its tributaries;

WHEREAS the lake is a significant source of drinking water, as well as being integral for local recreation, tourism, agriculture and other key economic drivers;

WHEREAS the previous federal government funded a "Lake Simcoe Clean-Up Fund" of \$65 million over 10 years between 2007-2017, but that fund has not been renewed;

WHEREAS during the 2019 federal election, the Hon. Chrystia Freeland committed \$40 million over 5 years towards Lake Simcoe;

WHEREAS during the 2021 federal election, the Liberal Party of Canada committed to "Implement a strengthened Freshwater Action Plan, including an historic investment of \$1 billion over 10 years. This plan will provide essential funding to protect and restore large lakes and river systems, starting with the Great Lakes-St. Lawrence River System, Lake Simcoe";

WHEREAS the Conservative Party of Canada also committed to re-funding the Lake Simcoe Clean-Up Fund in the 2019 and 2021 general elections with an investment of \$30 million over five years;

BE IT THEREFORE RESOLVED THAT the Town of East Gwillimbury supports the federal funding for a Lake Simcoe Restoration Fund that represents a significant percentage of the overall Freshwater Action Plan Fund, with funding in excess of previous commitments, beginning in the 2022 budget; and

THAT Council respectfully requests that such funding be used to undertake:

- Shoreline mitigation and restoration, including in the tributaries of the Holland River, Maskinonge River and Black River, and the Holland Marsh,
- Projects to ameliorate contaminated sites in the watershed,
- Upgrades to help retrofit municipal infrastructure such as wastewater and stormwater facilities to decrease total current discharges from existing facilities,
- Planting of 250,000 trees in the watershed, the conservation of more forests and wetlands under the auspices of the Lake Simcoe Region Conservation Authority (LSRCA), to make significant progress towards the Lake Simcoe Protection Plan goal of 40% of the watershed area being protected natural land; and

THAT a copy of this resolution, along with a letter from the Mayor, be sent to the federal Minister of Finance; the Minister of the Environment and Climate Change; the President of the Treasury Board; the Members of Parliament for York— Simcoe, Newmarket—Aurora, Barrie—Springwater—Oro-Medonte, Barrie— Innisfil, Simcoe North, Haliburton—Kawartha Lakes—Brock, and Durham; and to all Lake Simcoe-region municipalities and the LSRCA, with a request for their endorsement.

NOW THEREFORE BE IT RESOLVED THAT the Council of the Corporation of the Township of Lake of Bays hereby requests that Transport Canada amend the Canada Shipping Act 2001 by adding the following to the Act:

- All vessel greywater be discharged into a holding tank and disposed of as per Provincial regulations for new vessels; and
- All floating accommodations are required to conform to all Provincial and municipal regulations and by-laws.

AND FURTHER THAT the Council of the Corporation of the Township of Lake of Bays hereby requests that Northern Development, Mines, Natural Resources and Forestry (NDMNRF) amend Ontario Regulation 161/17 to include the following:

- Post signs to restrict floating accommodation/camping on the water in southern Ontario (Muskoka south) and that a permit from the NDMNRF is required and a permit will not be granted without the consent of the local municipality;
- Camping is reduced from 21 days to 7 days;
- Not permit any camping on the water within 300m of a developed lot or within a narrow water body of 150m; and
- Should a municipality have more restrictive by-laws related to camping, these by-laws would apply.

I am writing to you today to make a pre-budget submission in accordance with a motion presented by my colleague Councillor Jonathan Scott and passed unanimously by our Town Council asking that the federal government fulfil bipartisan commitments towards creating a Lake Simcoe Restoration Fund in the upcoming federal budget.

The motion is enclosed for your reference.

As you know, both local Liberal and Conservative MPs ran on the promise of restoring and exceeding funding that used to exist to help protect Lake Simcoe under the auspices of the Lake Simcoe Clean-up Fund. You yourself made such a commitment of a \$40-million fund during the 2019 election in Barrie. The commitment to a billion-dollar Freshwater Action Fund, which would include funding for Lake Simcoe, is in the Hon. Steven Guibeault's mandate letter as Minister of the Environment and Climate Change.

We ask that funding greater than previous commitments be invested to protect the Lake Simcoe watershed in this year's budget. Such funding should be over and above previous commitments given that funding for the Lake has been in hiatus since the previous fund expired in 2017, and due to inflationary pressures. As the motion outlines, such funding could be used for land conservation, shoreline restoration, cleaning up contaminated sites, reducing discharges from existing wastewater treatment plants, and other tangible means to restore the health of the watershed.

Our region, and Bradford West Gwillimbury in particular, is growing, and so we need to take environmental mitigation and restoration efforts seriously, alongside a federal partner.

I understand this motion has also passed in the Town of Georgina, and is being considered by other municipalities across our region, demonstrating, I believe, the great unity in our area for federal action to protect Lake Simcoe.

B. A \$1 billion penalty to the 407 ETR operators was forgiven by the province for failure to reduce tolls during COVID, to meet 401 Hwy traffic reduction targets by attracting drivers. This amounts to a subsidy of more than \$1 Billion annually for vehicle owners that could be restored and used to subsidize freight vehicles to encourage their use of the underutilized 407.
- B. A \$1 billion penalty to the 407 ETR operators was forgiven by the province for failure to reduce tolls during COVID, to meet 401 Hwy traffic reduction targets by attracting drivers. It is expected the same penalty will be forgiven for 2021. However, actually collecting the penalty would provide another \$1 billion to subsidize truckers using the 407;

NOW THEREFORE BE IT RESOLVED That the Town of Halton Hills continue its strong opposition to the environmentally destructive 413 Hwy;

AND FURTHER THAT the Town of Halton Hills strongly supports provincial subsidies that promote increased diversion of commercial truck traffic from the 401 Hwy to the under-utilized 407 ETR;

AND FURTHER THAT the Town of Halton Hills request the Province of Ontario work with 407 International Inc. to devise strategies to increase 407 ETR usage and enforce financial penalties established to encourage tolls that attract more drivers to use the 407 instead of the 401;



On behalf of the Council of The Corporation of the City of Barrie, I wish to advise that on March 7, 2022, City Council adopted the following resolution regarding a Plan of Action to Address Joint and Several Liability:

#### **REQUEST TO THE PROVINCE OF ONTARIO FOR A PLAN OF ACTION TO ADDRESS** 22-G-064 JOINT AND SEVERAL LIABILITY

WHEREAS the cost of municipal insurance in the Province of Ontario has continued to increase with especially large increases going into 2022; and

WHEREAS Joint and Several Liability continues to ask property taxpayers to carry the lion's share of a damage award when a municipality is found at minimum fault; and

WHEREAS these increases are unsustainable and unfair and eat at critical municipal services: and

WHEREAS the Association of Municipalities of Ontario outlined seven recommendations to address insurance issues including:

- 1. That the Provincial Government adopt a model of full proportionate liability to replace joint and several liability.
- 2. Implement enhancements to the existing limitations period including the continued applicability of the existing 10-day rule on slip and fall cases given recent judicial interpretations and whether a 1-year limitation period may be beneficial.
- 3. Implement a cap for economic loss awards.
- 4. Increase the catastrophic impairment default benefit limit to \$2 million and increase the third-party liability coverage to \$2 million in government regulated automobile insurance plans.

- 5. Assess and implement additional measures which would support lower premiums or alternatives to the provision of insurance services by other entities such as non-profit insurance reciprocals.
- 6. Compel the insurance industry to supply all necessary financial evidence including premiums, claims and deductible limit changes which support its own and municipal arguments as to the fiscal impact of joint and several liability.
- 7. Establish a provincial and municipal working group to consider the above and put forward recommendations to the Attorney General.

**NOW THEREFORE BE IT RESOLVED** that the Council for the Corporation of the City of Barrie call on the Province of Ontario to immediately review these recommendations despite COVID-19 delays, as insurance premiums will soon be out of reach for many communities and

**BE IT FURTHER RESOLVED** that this motion be provided to the Honourable Doug Ford, Premier of Ontario, the Honourable Peter Bethlenfalvy, Minister of Finance, the Honourable Doug Downey, Attorney General of Ontario and MPP for Barrie-Springwater, the Honourable Andrea Khanjin, MPP for Barrie-Innisfil, and all Ontario municipalities.



A history of innovation, a future of hope,

Lupus Ontario is the largest Canadian provincial organization focused on improving the lives of lupus patients and their families. The organization was founded in 1978 by Honey Agar and Linda Ethier, two lupus patients who were being treated in hospital and were very frustrated by the lack of knowledge and treatment for the disease. Originally the created as an arm of the Arthritis Society, Lupus Ontario's mission is to provide vital support, education, awareness, advocacy and research through the fundraising efforts of our staff and volunteer community to help those with lupus live longer, healthier and better lives.

In 1987, Lupus Ontario raised over one million dollars to establish the Lupus Databank Research Program at Toronto Western Hospital. This databank continues to be an invaluable asset to Canadian and global researchers who are studying treatments and potential cures for lupus. To date, the Databank has provided data for hundreds of research projects aimed at better management of lupus. "As the database has grown, what we can learn from it has grown immensely," says Dr. Murray Urowitz, Director, Centre for Prognosis Studies in the Rheumatic Diseases. "We're discovering things that change the way we treat lupus." In 1987, the Lupus Ontario also began to fund four lupus clinics across the province to help them with their education programs and research. Subsequently, this increased to six provincial lupus clinics.

In 1990, the organization established the Geoff Carr Lupus Research Fellowship in honour of the late Geoff Carr, a member of the Association of Commercial Travellers. To date, this annual Fellowship has funded 30 medical Fellows for a total of almost \$2 million. These medical residents come from across Canada and around the world to learn best practices for diagnosing and treating lupus patients and to participate in research studies.

Lupus is an autoimmune disease where the body attacks itself causing inflammation, pain, and possible organ damage. Five million people suffer from lupus globally and there is currently no cure. Nine out of ten lupus patients are women, usually diagnosed between the ages of 15 and 45. Help us unmask this insidious disease, support the research of innovative treatments and screening mechanisms, and ultimately develop a cure.
